Mexico City

It requires an institutional redesign not only in the executive power, but also in the bodies that are responsible for managing responsibilities through administrative and criminal means. This requires creative solutions that respond efficiently to the needs of the population by transforming public administration through the implementation of integral accountability mechanisms that guarantee the exercise of fundamental rights.

I. CONCEPTUAL NOTE

The constitutional reforms and new laws that give life to the National Systems of Control, Transparency and Anti-Corruption, require from articulation and institutional collaboration to achieve effective counterweights and greater citizen vigilance and accountability in the exercise of public power. Today, discretionary decision-making, complicity, private interest networks that dominate the bureaucratic sector and the secrecy culture contribute to corruption and practices that generate impunity.

In a country with strong regional asymmetries, the challenge is twofold: it is not only about having resources and generating capacities, but also about restoring the link between citizenship and government in a distrust context.
