















International Seminar:

I. OBJECTIVE

The seminar's main objective is to review the route to designa n effective public policy regarding accountability. Through comparative experiences, the regulatory and institutional advances that have been made in such matter as well as the favorable context for its requirement and consolidation, will be known.

II. MECHANICS OF THE EVENT

- 1. The event will be carried out in a day and a half. Four multidisciplinary panels, two master conferences and a table of conclusions will be set up. All sessions will address different angles involving the design of a public policy concerning accountability. Case studies will be favored.
- 2. In the International Seminar, attendees will be in contact with civil actors, as well as from academic institutions public and international institutions, who will be in charge of leading the sessions. Each panel will be moderated by a specialist who will contextualize the mexican context for discussion.
