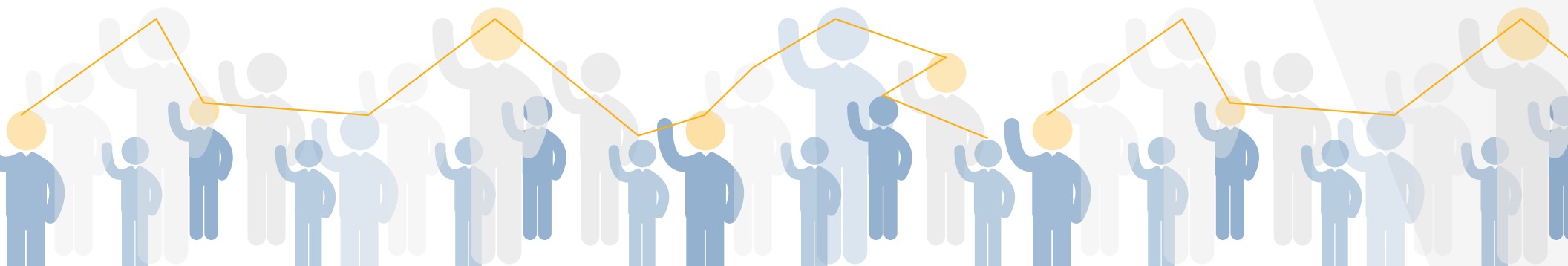

## ● OBJECTIVE

The purpose of the Seminar is to discuss public policy proposals based on applied research, specific case studies and international experiences for tackling corruption effectively and for building a public responsibility system in complex societies.

## METHOD
